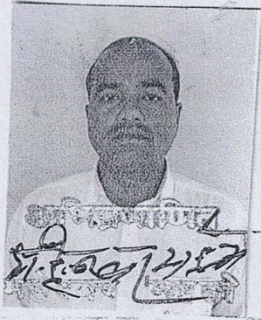

4. FORMATION OF EXECUTIVE COMMITTEE






